

AMENDMENT NO. 1

NEW YORK CITY SCHOOL CONSTRUCTION AUTHORITY

PROJECT LABOR AGREEMENT

WHEREAS, the New York City School Construction Authority (“SCA”), and the Building and Construction Trades Council of Greater New York and Vicinity (“BCTC”) have entered into a Project Labor Agreement for certain rehabilitation and renovation work performed under the SCA’s Capital Improvement Program (“CIP”) (“Program Work”) for Fiscal Years 2015 to 2019 in a manner designed to afford the lowest costs to the SCA, and the Public it represents, and the advancement of permissible statutory objectives; and

WHEREAS, the International Union of Operating Engineers (“OE”), Locals 14 - 14B and 15 - 15D, historically have not been, and are not currently, signatory to the PLA; and

WHEREAS, the SCA, the BCTC and OE have achieved an agreement whereby the OE, Locals 14 - 14B and 15 - 15D, have agreed to participate in, abide by, and execute the SCA PLA; and

WHEREAS, the parties have agreed to amend the SCA PLA to provide for the participation in and execution of the PLA by the OE, Local 14 - 14B and 15 - 15D; and

NOW THEREFORE, the SCA, the BCTC and the OE Local 14 - 14B and 15 - 15D, in consideration of the mutual promises and covenants herein contained, mutually agree as follows:

1. Effective July 1, 2017, the PLA will be amended as follows:
 - A. The OE Local 14 - 14B and 15 - 15D will become parties to the PLA by signing this Amendment, and shall become participating signatory local unions.
 - B. The OE Local 14 - 14B and 15 - 15D collective bargaining agreements will become “Schedule “A” Agreements within the meaning of the PLA.
2. The SCA will include this Amendment on its website and a link to the website will be included in all bid packages.

3. The form Affidavit of Project Labor Agreement assenting to the PLA shall be modified to refer to this Amendment.

4. This Amendment may be signed by the parties in counterparts.






